Effect of Safety Audit If the operator passes the safety audit, it will be issued a safety audit certificate, valid for a period specified by the auditor up to a maximum of three years. All operators must obtain a safety audit certificate and be registered by 1 November 2014, or earlier, if required to do so by the Ministry. Any operator who fails to do so, but continues to provide adventure activities, will be committing an offence under the Health and Safety in Employment Act 1992 which ...
