Since April 2016, the Personal Savings Allowance means basic rate taxpayers are able to earn up to £1,000 in savings interest tax-free, while 40% taxpayers can get £500 in tax-free interest and anyone paying 45% tax will have no tax-free allowance. Any amounts of interest above these tax-free amounts are taxed at the marginal rate applying to that person (20%, 40% or 45%).
